Verification:

- Mobile and Aadhaar → through OTP verification mechanism
- PAN → through Income Tax Database
- Bank account details → by initiating small transfer (usually ₹100) which would provide details on name of account holder, bank name, IFSC code, also called Penny Drop Mechanism.
- Documents other than Aadhaar → through Digilocker / e-Sign mechanism
